ORDER

An application for affiliation of an Unaided Self-financing B.Ed. Training College at Nellimoodu, Thiruvananthapuram during the academic year 2004—2005 was received from the Manager, New Higher Secondary School Management Committee, Nellimoodu P.O., Thiruvananthapuram, vide paper read as (1).

Vide paper read as (2), the Syndicate at its meeting held on 16.12.2003 decided not to proceed with the applications for affiliation in respect of new B.Ed. Training Colleges during 2004—2005 and not to appoint Inspection Commission for the same since the Government has not granted NOC to the B.Ed. Colleges, already recommended by the University during 2003—2004.

Vide paper read as (3), the Honourable High Court of Kerala has directed the University to take a decision on the application for affiliation filed by the Petitioner, in accordance with law within two weeks from the date of production of the Order.

Vide paper read as (4), the Syndicate at its meeting held on 19.11.2004 considered in the light of the Order from the Honourable High Court of Kerala, the question of recommending NOC for the Training College at Nellimoodu by the New Higher Secondary School, Nellimoodu for the academic year 2005—2006 and decided to authorize the Vice-Chancellor to take a decision after obtaining legal opinion. On the basis of the positive recommendation of the Legal Adviser, the Vice-Chancellor has

decided to grant NOC to the proposed B.Ed. Training College at Nellimoodu, Thiruvananthapuram during the academic year 2005—2006.

Vide paper read as (5), the Government of Kerala has accorded sanction to the Unaided B.Ed. Training College by the New Higher Secondary School, Nellimoodu, Thiruvananthapuram from the academic year 2004—2005, and subject to recognition by the NCTE, affiliation by the University concerned and subject to the decision of the Honourable High Court of Kerala in WA 379/04 and 474/04 and connected cases.

Vide paper read as (6), the National Council for Teacher Education granted recognition to the New B.Ed. College, Nellimoodu, Thiruvananthapuram for the secondary course of one year duration from the academic session 2004—2005 with an annual intake of 100 students.

Vide paper read as (7), the Government of Kerala has accorded sanction for starting the B.Ed. Degree Course in New B.Ed. College, Nellimoodu, Thiruvananthapuram in accordance with the relevant Rules and Regulations of the University concerned and subject to formal decision of the Honourable High Court in the Writ Appeals.

Vide paper read as (8), the Syndicate at its meeting held on 12.05.2005 decided that provisional affiliation be granted for the New B.Ed. College, Nellimoodu, Thiruvananthapuram for the academic year 2005—2006 with an annual intake of 100 students for the B.Ed.Degree Course in the following optional subjects:

- 1. Natural Science
- 2. Mathematics
- 3. Social Science
- 4. Commerce and
- 5. English

with the stipulation that there should be a minimum of ten candidates in each subject.

Vide paper read as (9), the decision of the Syndicate was intimated to the Educational Agency directing them to fulfil the remaining formalities for granting provisional affiliation.

Vide paper read as (10), (11) & (12), the Manager, New Higher Secondary School Management Committee, Nellimoodu, Thiruvananthapuram has fulfilled the prescribed formalities for obtaining provisional affiliation to the Training College and also executed the prescribed Agreement and Letter of Undertaking.

Sanction has, therefore, been accorded by the University to grant provisional affiliation to the **New B.Ed. College**, Nellimoodu, Thiruvananthapuram under the New Higher Secondary School Management Committee, Nellimoodu, Thiruvananthapuram to start the B.Ed. Degree Course for the academic year 2005—2006. The total strength of admission shall be 100 and the minimum number of candidates in each subject shall be ten (10). The following are the optional subjects sanctioned:

- 1. Natural Science
- 2. Mathematics
- 3. Social Science
- 4. Commerce
- 5. English

The provisional affiliation granted is subject to the condition that there will not be any financial commitment on the part of the Government or the University.
